

AGREEMENT FOR EXTENSION OF MORTGAGE

WHEREAS, Wilbur G. Golightly and Donna C. 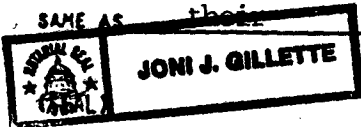
