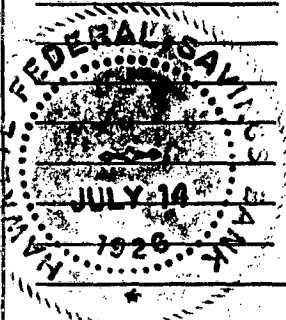


RELEASE (Corporation)

A parcel of land in the N1/4 of the SE1/4 of Section 30, Township 76 North, Range 26 West of the 5th P.M., Madison County, Iowa, more particularly described as follows: Commencing at the NW corner of the NE1/4 of the SE1/4 of said Section 30; thence South 54°21'24" West 201.54 feet to the point of beginning; thence South 05°21'47" West 452.15 feet; thence South 88°47'22" East 348.08 feet; thence North 05°13'00" East 468.51 feet; thence South 88°30'43" West 348.46 feet to the point of beginning, containing 3.66 acres, more or less, together with an easement for ingress and egress one rod wide, the centerline being described as follows: Commencing at the Northwest corner of the said Northeast 1/4 of the Southeast 1/4; thence South 54°21'24" West 201.54 feet; thence North 88°30'43" East 224.92 feet to the point of beginning; thence North 08°36'06" East 118 feet, more or less to the Southerly Right of Way Line of State Highway 92, and also together with an easement for the construction and maintenance of a well and water line one rod wide, the centerline being described as follows: Commencing at the Northwest corner of the said Northeast 1/4 of the Southeast 1/4; thence South 19°57'02" West 603.85 feet to the Southwest corner of parcel herein described; thence South 88°47'22" East 87.97 feet to the point of beginning; thence South 34°30'35" West 446 feet to the terminus; and said parcel is subject to a transmission line easement recorded in Book 82, Page 384 at the Office of the Madison County Recorder.

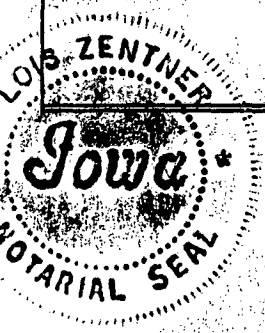
