

ASSIGNMENT OF MORTGAGE/DEED OF TRUST

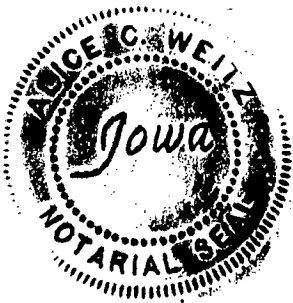

Bergstrom and Rebecca L. Bergstrom, husband and wife, as Mortgagor/Trustor/Grantor/Borrower, United Federal Savings and Loan Association of Des Moines, as Mortgagee/Beneficiary/Grantee/Lender, (and if applicable) _____, as Trustee, and recorded on December 23, 1977, in Book 127, at Page 444, as Document Number 1220, together with the note, debt and claim secured by the Mortgage/Deed of Trust and the covenants contained in the Mortgage/Deed of Trust.
