

**ASSIGNMENT OF MORTGAGE/DEED OF TRUST**

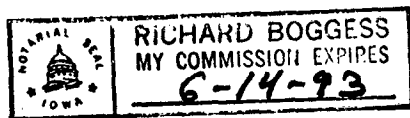
