Zeutenhorst, a single person, as Mortgager/Truster/Grantor/Borrower, United Federal Savings Bank of Iowa, as Mortgagee/Beneficiary/Grantee/Lender, and (if applicable), as Trustee, and recorded on April 27, 1989, in Book 152, at Page 632-633, as Document Number 2114, County of Madison, State of Iowa, together with the note, debt and claim secured by the Mortgage/Deed of Trust and the covenants contained in the Mortgage/Deed of Trust.

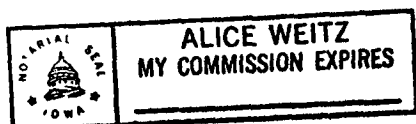
