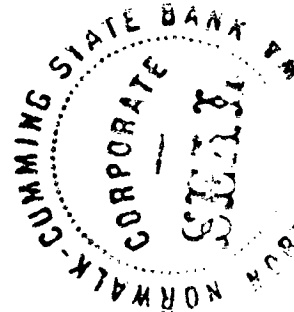


RELEASE OF LIEN
