

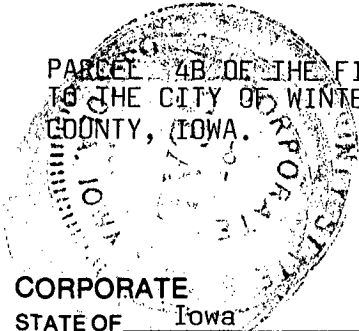
PARTIAL **RELEASE OF REAL ESTATE MORTGAGE**
