

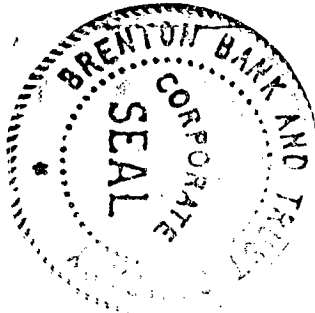
RELEASE OF REAL ESTATE MORTGAGE
