

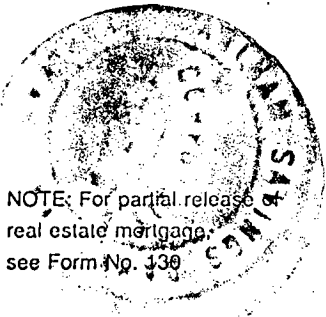
### RELEASE OF REAL ESTATE MORTGAGE
