Mortgage is hereby declared fully paid , satisfied and released.

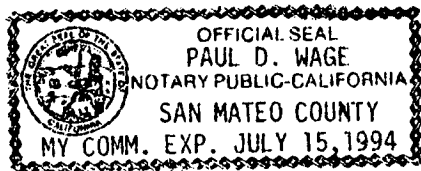
