AGREEMENT FOR EXTENSION OF MORTGAGE

Whereas, Nickolas L. Boyle and Beverly A. The Borrower hereby covenants and warrants that said mortgage is a lien on the real estate therein described and that it shall continue and remain as security for the payment of the Note described thereon until paid; and in case of failure to comply with any one of the conditions hereof or any of the conditions of said Mortgage, all the provisions of said Mortgage becoming a part of this instrument, then the whole debt may at once become due and collectable at the option of the Government. All covenants and conditions of said Mortgage shall remain in force except as modified by this instrument.
