Addendum

1. A part of Out Lot 1 in Laughridge and Cassiday's Addition to Winterset, Madison County, Iowa, more particularly described as follows: Beginning at the northwest corner of Out Lot 1 of Laughridge and Cassiday's Addition; thence east, along the north line of said Out Lot 1, 100.00 feet; thence south, parallel with the west line of said Out Lot 1, 118.5 feet to a point 8.5 feet north of the centerline of an existing spur track; thence westerly, along a line parallel with and 8.5 feet northerly from said spur track, 100.0 feet to a point on the west line of said Out Lot 1; thence North 120.4 feet to a point of beginning. All of above parcel being in Out Lot 1 of Laughridge and Cassiday's Addition to Winterset, Madison County, Iowa.
