## RESOLUTION PROPOSING TO VACATE A PORTION OF A CITY STREET RIGHT OF WAY AND SETTING PUBLIC HEARING ON THE PROPOSAL

WHEREAS, the City proposes to vacate a portion of a City street right of way and to dispose of its interest in the real estate formerly used as a City street right of way;

WHEREAS, the portion of the City street right of way is legally described as:

The Easterly 30.00 feet of Right of Way adjacent to Lot 4 of the Replat of Lot 3 of the Gold Buffet Subdivision, an Official Plat in the City of Winterset, Madison County, Iowa, more particularly described as follows:

Beginning at the Southwest Corner of said Lot 4; THENCE North 89°57'20" West, extending the South line of said Lot 4, a distance of 30.00 feet; THENCE North 00°00'00" East, parallel with the West line of said Lot 4, a distance of 174.98 feet; THENCE South 89°59'03" East, along an extension of the North line of Said Lot 4, a distance of 30.00 feet to the Northwest corner of Said Lot 4; THENCE South 00°00'00" West, along the West line of said Lot 4 a distance of 175.00 feet to the POINT OF BEGINNING, containing 5,250 square feet, more or less.

NOW, THEREFORE, BE IT RESOLVED that the proposal to vacate a portion of a City street right of way as described above be and is hereby approved in all respects as provided by the prior Resolution of the City Council of Winterset, Iowa.

BE IT FURTHER RESOLVED that the Mayor and City Administrator be and are hereby authorized and directed to take all necessary steps to show the revised City street map.

BE IT FURTHER RESOLVED that the City Administrator shall file a true copy of these proceedings with the Madison County Recorder.
