A Retracement Plat of Survey of the East 1/2 of the Northwest !/4 (E 1/2 NW 1/4) of Section 16, Township 74 North, Range 27 West of the 5th P.M., Madison County, Iowa. Said E 1/2 NW 1/4 having been divided into the Northeast 1/4 Northwest 1/4 (NE 1/4 NW 1/4) and Southeast 1/4 Northwest 1/4 (SE 1/4 NW 1/4) for purposes of conveyance. SUBJECT to all easements of record. Containing 79.35 acres of land.

ALSO subject to a 40.00 easement for ingress/egress cross a portion of the West 1/2 of the Northeast 1/4 (W 1/2 NE 1/4) of said Section 16. Said easement more particularly described as follows:

All that land lying 40.00' Southerly of an existing fenceline described as Beginning at a point that is $N00^{\circ}14'38''$ E a distance of 620.47' from the Center of said Section 16; thence N85°23′55″E, along said fenceline, 1052.33′; thence N89°41′57″E, along said fenceline, 152.50′ to a point 40′ West of an existing fence corner post; thence N01°38′48″E, a distance of 40.02′; thence N89°24′57″E, a distance of 130.71′ to an existing fence corner post and the Point of Termination of said easement
