This deed is given for the purpose of holding title to the above described real estate as originally intended by the parties.

Parcel "F", which is the West Half of the Southwest Quarter of the Northwest Quarter of Section 24, Township 74 North, Range 26 West of the 5th P.M., Madison County, Iowa, more particularly described as follows: Beginning at the West Quarter corner of Section 24, Township 74 North, Range 26 West of the 5th P.M., Madison County, Iowa; thence North 0 degrees 00'00" East along the West line of the Southwest Quarter of the Northwest Quarter of said Section 24, 1319.35 feet to the Northwest corner of the Southwest Quarter of the Northwest Quarter of said Section 24; thence North 85 degrees 37'45" East along the North line of the Southwest Quarter of the Northwest Quarter of said Section 24, 663.99 feet; thence South 0 degrees 09'34" West, 1317.03 feet to a point on the South line of the Southwest Quarter of said Section 24; thence South 85 degrees 24'14" West along the South line of the Southwest Quarter of the Northwest Quarter of said Section 24, 660.52 feet to the Point of Beginning.
