- I, Lynne C. Walker, being first duly placed upon oath depose and state:
- Donna C. Hoover, (hereinafter referred to as "Decedent") died, a resident of Madison County, Iowa, on the 17th day of December, 2010.
- 2. Decedent was survived by her spouse, Frederick J. Hoover.
- 3. I am the daughter of Donna C. Hoover and Frederick J. Hoover.
- 4. At the time of Decedent's death, record title to the following described real estate was vested in Frederick J. Hoover and Donna C. Hoover, as joint tenants with full right of survivorship, and not as tenants in common:

The West Half of the Northwest Quarter (W_2 NW%) and the Northeast Quarter of the Northwest Quarter (NE% NW%) of Section Sixteen (16), in Township Seventy-four (74) North, Range Twenty-six (26) West of the 5th P.M., Madison County, Iowa,

and

That portion of the Southeast Quarter of the Northwest Quarter (SE% NW%) of Section Sixteen (16), Township Seventy-four (74) North, Range Twenty-six (26) West of the 5th P.M., Madison County, Iowa, lying North of the public road crossing said tract.

5. There is no federal estate tax liability or Iowa inheritance tax or Iowa estate tax liability as a result of Donna C. Hoover's death. (For deaths occurring after July 1, 1997, a surviving spouse as well as parents, grandparents, great grandparents, and other lineal ascendants; children, including legally adopted children, as well as step children and grandchildren, great grandchildren, and other lineal descendants, are exempt from Iowa inheritance tax.)

Therefore, I hereby request that the County Auditor of Madison County, Iowa, list the above described real estate for taxation in the name of Decedent's surviving spouse, Frederick J. Hoover, only, from and after this date.
