All that part of Cherry Street in the Original Town of Earlham, Madison County, Iowa, lying South of the South boundary line of Railroad Avenue, and North of the North line of the right of way of the Chicago, Rock Island and Pacific Railroad Company in said town; AND Parcel "C" located in Lot One (1), Block Thirten (13), Original Town of Earlham, Madison County, Iowa, containing 0.179 acres, as shown in Plat of Survey filed in Book 2003, Page 4794 on August 13, 2003, in the Office of the Recorder of Madison County, Iowa; AND Parcel "A" located in the former Chicago, Rock Island and Pacific Railroad Company's Depot Grounds lying South of Lot One (1), Block Thirteen (13), Original Town of Earlham, Madison County, Iowa, containing 15,029 square feet, as shown in Plat of Survey filed in Book 2, Page 236 on December 21, 1994, in the Office of the Recorder of Madison County, Iowa, EXCEPT Parcel "D", a part of said Parcel "A", containing 0.171 acres, as shown in Plat of Survey filed in Book 2003, Page 4795 on August 13, 2003, in the Office of the Recorder of Madison County, Iowa.
