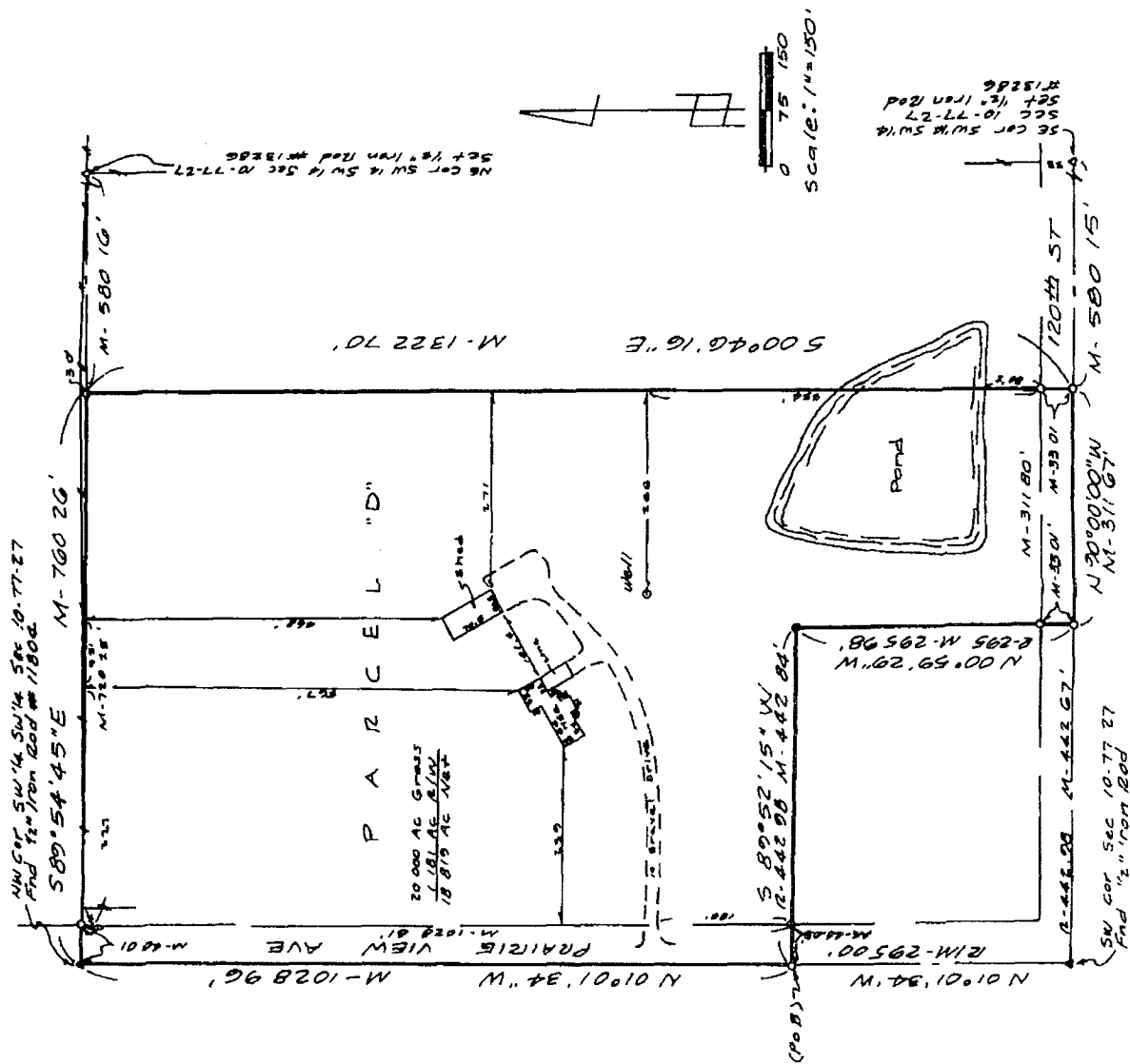
Commencing at the Southwest corner of the SW 1/4 of said Section 10,
