




Commencing at the Southeast Corner of the Northwest Fractional Quarter of the Northwest Quarter of Section 7, Township 75 North, Range 27 West of the 5th P.M., Madison County, Iowa thence North 00°33'20" East 185.09 feet along the East line of said Northwest Fractional Quarter of the Northwest Quarter to the Point of Beginning; thence North 47°00'35" West 167.00 feet to a point at the centerline of a county road; thence North 46°49'39" East 204.14 feet along the centerline of a county road; thence 171.59 feet Northeasterly on a 357.00 foot radius curve concave Northwesterly; which is the county road center line and has 169.94 foot chord bearing North 33°03'11" East; to the Westerly right-of-way of a vacated county road; thence South 07°07'44" West 37.70 feet; thence South 01°22'16" East 302.25 feet along the Westerly right-of-way of a vacated county road; thence South 65°10'44" West 134.38 feet along the Northwest line of a parcel currently owned by the City of Winterset to the Point of Beginning. Parcel contains 1.047 acres including 0.196 acres of county road right-of-way.
