AFFIDAVIT OF SURVIVING SPOUSE FOR CHANGE OF TITLE TO REAL ESTATE

STATE OF IOWA, COUNTY OF MADISON, ss:

I, Francis J. McAllister, Jr., being first duly sworn on oath, depose and state as follows:

- 1. Russell M. Lander died on June 17, 2012. On the 26th day of June, 2012, the Last Will And Testament of Russell M. Lander, deceased, bearing date of the 22nd day of December, 2005, was admitted to probate and Francis J. McAllister, Jr. was appointed Executor of the estate, which estate is now being administered in Madison County District Court Probate Number ESPR012534.
- 2. Russell M. Lander is the surviving spouse of Alice M. Lander, who died on the 29th day of February, 2012.
- 3. The following described real estate was owned only by Russell M. Lander and Alice M. Lander, as joint tenants with full rights of survivorship at the time of Alice M. Lander's death:

The Southwest Quarter (¼) of the Southeast Quarter (¼) of Section Twenty-four (24), Township Seventy-seven (77) North, Range Twenty-seven (27) West of the 5th P.M., Madison County, Iowa; EXCEPT Parcel "C" located therein, containing 5.000 acres as shown in the Plat of Survey filed in Book 2003, Page 7195 on December 5, 2003, in the Office of the Recorder of Madison County, Iowa.

- 4. Title was conveyed to Russell M. Lander and Alice M. Lander by Warranty Deed dated and filed on April 3, 1975 in Deed Record Book 104 at Page 678 in the Office of the Madison County Recorder; and by Warranty Deed dated and filed January 7, 2004 in Book 2004 at Page 84 in the Office of the Madison County Recorder.
- 5. I hereby request that the Auditor enter this information on the transfer books pursuant to Section 558.66 of the Iowa Code.
- 6. Form 706, United States Estate Tax return, IS NOT required to be filed as a result of the death of Alice M. Lander.

7. An Iowa inheritance tax return is not required to be filed pursuant to Iowa Code Section 450.22 subsection 3 for Alice M. Lander.
