1. The Northeast Quarter of the Southeast Quarter (NE 1/4 SE 1/4 and a part of the Southeast Quarter of the Northeast Quarter (SE 1/4 NE 1/4) all in Section 1, Township 76 North, Range 27 West of the 5th P.M., Madison County, Iowa, more particularly described as follows:

Beginning at an iron pin at the Southeast corner of said NE 1/4 SE 1/4; thence N89°55'55" W a distance of 1296.23' to an iron pin; thence N00°37'59" E a distance of 1323.69' to an iron pin; thence N00°13'25" E a distance of 93.85' to a 60d zinc nail set in top of post; thence N87°07'35" E a distance of 1288.50'; thence S00°46'00" W a distance of 147.94' to an iron pin; thence S00°09'24" W a distance of 1335.68' to an iron pin; to the point of beginning.
