Pursuant to Iowa Trust Code Section 633A.4604, this Certification of Trust is signed by the currently acting Trustee of the Wilma Maxine Busch Declaration of Trust Dated September 6, 2007, who declares:

1. The Grantor of the trust was Wilma Maxine Busch, who died on September 2, 2011. The trust became irrevocable upon her death.
2. The original Trustee of the trust was Wilma Maxine Busch. Prior to her death, Wilma Maxine Busch resigned as Trustee on August 24, 2011 and pursuant to the terms of the Trust, Denny Lowell Busch became the Successor Trustee.
3. The tax identification number of the trust is the Social Security number of Wilma Maxine Busch.
4. Title to assets held in the trust will be titled as:

Denny Lowell Busch, Trustee of the Wilma Maxine Busch Declaration of Trust Dated September 6, 2007, and any amendments.
5. An alternative description will be effective to title assets in the name of the trust or to designate the trust as a beneficiary if the description includes the name of at least one initial or successor Trustee, any reference indicating that property is being held in a fiduciary capacity, and the date of the trust.
6. Excerpts from the trust document that establish the trust, designate the Trustee, and set forth the powers of the Trustee will be provided upon request. The powers of the Trustee include the power to acquire, sell, assign, convey, pledge, encumber, lease, borrow, manage, and deal with real and personal property interests.
7. Real estate and other assets held by the Trust shall be distributed pursuant to a Settlement Agreement and Release dated October 3, 2012, made and entered into by [a] Denny Lowell Busch in his capacity as Trustee of the trust, [b] Denny Lowell Busch in his individual capacity and [c] Marilyn A. Myers in her individual capacity.
8. The terms of the trust provide that a third party may rely upon this Certification of Trust as evidence of the existence of the trust and is specifically relieved of any obligation to inquire into the terms of this trust or the authority of my Trustee, or to see to the application that my Trustee makes of funds or other property received by my Trustee.
9. The trust has not been revoked, modified, or amended in any way that would cause the representations in this Certification of Trust to be incorrect.

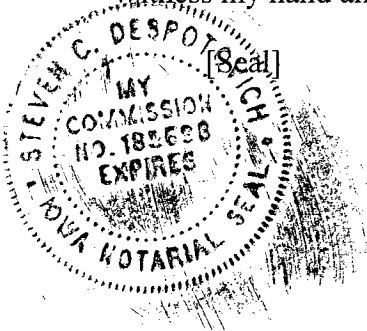


