

The North Half (N 1/2) of the Southwest Quarter (SW 1/4) of Section Fifteen (15), in Township Seventy-five (75) North, Range Twenty-seven (27) West of the 5th P.M., Madison County, Iowa; AND, all that part of the North Half (N 1/2) of the Southeast Quarter (SE 1/4) of Section Eight (8), in Township Seventy-five (75) North, of Range Twenty-seven (27) West of the 5th P.M., lying West of the Highway, the west line of which commences 1,081 feet East of the center of said Section Eight (8) and runs South, 15 degrees 20 minutes East, 790.5 feet; thence Southeasterly 599.6 feet along a 3,853 foot radius curve with central angle of 8 degrees 55 minutes; thence South 24 degrees 15 minutes East to a point on the South line of said 80-acre tract approximately 1,175 feet West of the southeast corner thereof, Madison County, lowa
