This deed is exempt according to Iowa Code 428A.2(15).

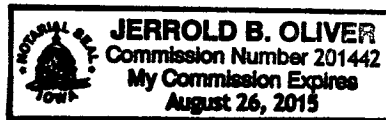

- 3) Lots 1, 2, 3, 4 and Outlot "D" of Westphal Subdivision, an Official Plat in the City of Earlham, Madison County, Iowa
