## **AFFIDAVIT**

I, Stanley L. Birchem, President of Madison Square Assisted Living Corp., being duly sworn upon oath, hereby state:

- 1. Madison Square Assisted Living Corp. purchased an assisted living facility known as Madison Square from Steve Reed Developments, Inc. on July 9, 2003.
- 2. As a part of the purchase, Madison Square Assisted Living Corp. received an Assignment of Right of First Refusal to Unit 207 of Jefferson Place in the City of Winterset, Iowa, the legal description of such unit being:

Unit #207 of Jefferson Place in the City of Winterset, Madison County, Iowa, and an undivided 1/23rd interest in the common elements and areas of Jefferson Place as shown in the Declaration of Condominium of Jefferson Place filed for record on April 14, 1995 in Town Lot Deed Record 60 at page 159 in the Madison County Recorder's Office together with any easements and appurtenant servient estates, including storage and parking lots.
