Addendum

1. Lot Two (2), Peterson Subdivision, City of Winterset, Madison County, Iowa,

Reserving an Easement to Grantors, Mark A. Peterson and Carol J. Peterson, over and across a strip of land 16 feet in width lying West of the West line of Lot One (1) of Peterson Subdivision to the City of Winterset, Madison County, Iowa. Grantees, Terrance Cowman and Sarah Cowman, shall maintain and keep in repair the easement area.

The following Restrictive Covenants shall apply to the above described real estate:

Grantees, Terrance Cowman and Sarah Cowman, their heirs, successors and assigns shall not construct more than one home on the above described real estate as long as Grantors, Mark A. Peterson and Carol J. Peterson, reside in the home now occupied by them on Lot One (1), Peterson Subdivision.
