EXHIBIT "A"

1. An undivided one-half interest in:

The Northeast Quarter (1/4) of the Southwest Quarter (1/4) and the Southeast Quarter (1/4) of Section Eighteen (18); and the Northwest Quarter (1/4) of the Southwest Quarter (1/4) of Section Seventeen (17), and a tract of land located in the Southwest Quarter (1/4) of the Southwest Ouarter (1/4) of said Section Seventeen (17), described as follows: Commencing at a point 13 rods and 5 links North of the Southwest corner of the Southwest Quarter (1/4) of Section Seventeen (17), running thence East 54 rods, thence North about 58 rods to the center of the bed of Middle River, thence down the channel of said river 26 rods to the East line of the Southwest Ouarter (¼) of the Southwest Quarter (¼), of Section Seventeen (17), thence North to the Northeast corner of said Southwest Quarter (1/4) of the Southwest Quarter (1/4), thence West to the Northwest corner thereof, thence South to the place of beginning; AND a tract of land located in the East Half (½) of the Southwest Quarter (¼) of Section Seventeen (17), described as follows: Commencing at the Northwest corner of the Northeast Quarter (1/4) of the Southwest Quarter (1/4) of Section Seventeen (17), thence running South 88 rods, thence North, 45° East, 38 rods and 9 links, thence North, 22½° West, 19 rods, thence North, 59½° East, 34 rods, thence up a branch North, 28° East, 36 rods and 13 links to the North line of said Northeast Quarter (1/4) of the Southwest Quarter (1/4) of Section Seventeen (17), thence West to the place of beginning; ALL in Township Seventy-five (75) North, Range Twenty-eight (28) West of the 5th P.M.. Madison County, Iowa.

2. An undivided one-half interest in:

The South Half (½) of the Northeast Quarter (¼) **AND** the Southeast Quarter (¼) of the Northwest Quarter (¼) **AND** the Northeast Quarter (¼) of the Southwest Quarter (¼), **ALL** in Section Twenty-nine (29), in Township Seventy-six (76) North, Range Twenty-eight (28) West of the 5th P.M., Madison County, Iowa, **EXCEPT** Parcel "A" located in the Southeast Quarter (¼) of the Northeast Quarter (¼) of said Section Twenty-nine (29), containing 4.497 acres, as shown in Plat of Survey filed in Book 2001, Page 2288 on June 4, 2001, in the Office of the Recorder of Madison County, Iowa.

3. An undivided one-half interest in:

The Southwest Quarter (1/4) of Section Thirty-three (33), Township Seventy-six (76) North, Range Twenty-eight (28) West of the 5th P.M., Madison County, Iowa; **except** that portion thereof conveyed to State of Iowa in Deed recorded July 14, 1966, in Book 94, Page 36.

An undivided one-half interest in:

The Northwest Quarter (1/4) of Section Thirty-three (33), Township Seventy-six (76) North, Range Twenty-eight (28) West of the 5th P.M., Madison County, Iowa, **EXCEPT** a parcel of land located therein, containing 5.000 acres, as shown in Plat of Survey filed in Farm Plat Book 2, Page 138 on March 2, 1989, in the Office of the Recorder of Madison County, Iowa; **AND EXCEPT** Parcel "A" located therein, containing 3.000 acres, as shown in Plat of Survey filed in Book 2, Page 547 on January 30, 1995, in the Office of Recorder of Madison County, Iowa; **AND EXCEPT** Parcel "B" located therein, containing 4.000 acres, as shown in Plat of Survey filed in Book 3, Page 181 on February 11, 1998, in the Office of Recorder of Madison County, Iowa; **AND EXCEPT** Parcel "C" located therein, containing 1.820 acres, as shown in Plat of Survey filed in Book 2003, Page 2149 on April 14, 2003, in the Office of Recorder of Madison County, Iowa.
