(Corporate/Business Entity Grantor)

For the consideration of One and no/100ths (\$1.00) Dollar(s) and other valuable consideration, EARLY CHAPEL CHRISTIAN CHURCH, a(n) nonprofit corporation organized and existing under the laws of the State of Iowa does hereby Convey to H H I CO. the following described real estate in Madison County, Iowa:

Parcel "B" located in the Northeast Quarter of the Southwest Quarter (NE¼ SW¼) of Section 2, Township 76 North, Range 29 West of the 5th P.M., Madison County, Iowa, containing 0.551 acres, as shown in Plat of Survey filed in Book 2013, Page 2143 on July 19, 2013, in the Office of the Recorder of Madison County, Iowa.

This transfer is for monetary consideration of less than \$500; therefore, this transfer is exempt from the Iowa real estate transfer tax and declaration of value and groundwater hazard statement filing requirements pursuant to Section 428A.2(21), Code of Iowa.

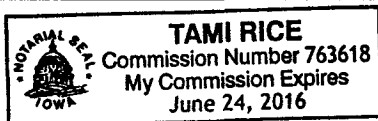
