- I, Marilyn Kay Maffin, being duly sworn on oath depose and state as follows:
- 1. I am the surviving spouse of Charles A. Maffin, deceased. Charles A. Maffin died on the 30<sup>th</sup> day of August, 2013.
- 2. The following described real estate was owned by this affiant, Marilyn Kay Maffin and Charles A. Maffin, wife and husband, as joint tenants with full rights of survivorship, and not as tenants in common, at the time of Charles A. Maffin's death, towit:

The South Half (S½) of the Northeast Quarter (NE¼) of Section Fourteen (14), in Township Seventy-seven (77) North, Range Twenty-nine (29) West of the 5<sup>th</sup> P.M., Madison County, Iowa, EXCEPT a tract described as follows: Commencing at the Northeast Corner of said Section Fourteen (14), thence South 00°00' 1,313.73 feet along the section line to the point of beginning; thence North 89°27' West 753.68 feet along the North line of the Southeast Quarter (SE1/4) of the Northeast Quarter (NE1/4) of said Section Fourteen (14), thence South 00°00' 289.00 feet, thence South 89°27' East 753.68 feet, thence North 00°00' 289 feet along the section line to the point of beginning, containing 5.000 Acres including 0.278 Acres of county road right-of-way.

The West Half (W1/2) of the Northwest Quarter (NW1/4) of Section Thirteen (13), in Township Seventy-seven (77) North, Range Twenty-nine (29) West of the 5<sup>th</sup> P.M., Madison County, Iowa.

- 3. I hereby request that the Auditor enter this information on the transfer books pursuant to Section 558.66 of the Code of Iowa.
- 4. I affirmatively state that the aggregate gross value of all property interests owned by Charles A. Maffin at the time of his death was below the filing requirements of a federal estate tax return and Iowa estate tax return, and that Charles A. Maffin's estate was not subject to federal estate tax, Iowa estate tax, or Iowa inheritance tax. Form 706, United States Estate Tax Return, is not required to be filed for Charles A. Maffin. Pursuant to Section 450.22(3), Code of Iowa, an Iowa inheritance/estate tax return was not required to be filed as a result of Charles A. Maffin's death.
