### PURCHASER'S AFFIDAVIT

RE: The East One-half of the Northeast Quarter (E1/2 NE1/4) of Section Twelve (12), Township Seventy-four (74) North, Range Twenty-nine (29) West of the 5th P.M., Madison County, Iowa, Excepting therefrom Parcel "A" as shown on Plat of Survey recorded October 16, 2001, in Book 2001, Page 4672, and more particularly described as follows:

thence South 87 degrees 54 minutes 18 seconds East a distance of 360.53 feet;

thence South 00 degrees 07 minutes 54 seconds West a distance of 272.30 feet;


thence South 65 degrees 04 minutes 51 seconds West a distance of 397.73 feet;
