AFFIDAVIT

STATE OF IOWA, COUNTY OF BOONE, ss:

- I, Lee R. Johnson, being first duly sworn, depose and state:
- 1. I was well and personally familiar with Francis R. Platt, a/k/a Francis Platt, and know that he died in Ames, Iowa, on September 4, 2013.
- 2. At the time of his death, he owned a life estate in the following described parcels of real estate:
 - A. The Southwest Quarter (1/4) of the Southeast Quarter (1/4) of Section Five (5); AND the North Half (½) of the North 105 2/3 rods of the West Half (½) of the Southwest Quarter (¼) of Section Four (4); AND the North Half (½) of the North 105 2/3 rods of the East Half (½) of the Southeast Quarter (1/4) of Section Five (5); ALL in Township Seventy-four (74) North, Range Twenty-nine (29) West of the 5th P.M., Madison County, Iowa.
 - B. The South One-half (½) of the following described real property: The North 105 2/3 rods of the West Half (1/2) of the Southwest Quarter (1/4) of Section Four (4) and the North 105 2/3 rods of the East Half (½) of the Southeast Quarter (¼) of Section Five (5); all in Township Seventy-four (74) North, Range Twenty-nine (29) West of the 5th P.M., Madison County, Iowa; AND an undivided One-half (1/2) interest in the following described real estate property: The Southeast Quarter (1/4) of the Southwest Quarter (1/4) and the East 500 feet of the Southwest Quarter (1/4) of the Southwest Quarter (1/4) of Section Thirty (30), and a tract described as commencing at the Northwest corner of the Northeast Quarter (1/4) of the Northwest Quarter (1/4) of Section Thirty-one (31), thence West 500 feet, thence South 904.5 feet, thence East 500 feet to a point 905.32 feet South of the point of beginning, thence East to a point 907.5 feet South of the Northeast corner of last described 40-acre tract, thence North 907.5 feet to said corner, thence West to the point of beginning, in Township Seventyfour (74) North, Range twenty-seven (27) West of the 5th P.M., Madison County, Iowa;


