## An undivided one-half interest:

The Northeast Quarter (1/4) of the Northwest Quarter (1/4) of the Northwest Quarter (1/4) except that part thereof which lies South and West of the public highway and containing 1 acre more or less, of Section Ten (10), and all that part of the Southwest Quarter (1/4) of the Southwest Quarter (1/4) of Section Three (3) lying East of the public highway running through said Last described tract, Except Parcel C thereof, all in Township Seventy-five (75) North, Range Twenty-seven (27) West of the 5<sup>th</sup> P.M., Madison County, Iowa

## **EXCEPT**

A parcel of land described as commencing at the Northeast Gorner of the Southeast Quarter (SE4) of the Northwest Quarter (NW4) of Section Ten (10), Township Seventy-five (75) North, Range Twenty-seven (27) West of the 5th P.H., Madison County, Iowa, thence South 0°00' 522.4 feet to the Point of Beginning; thence South 88°20' West 474.1 feet; thence South 0°42' West 116.7 feet; thence North 88°55' East 475.4 feet to the East line of said Southeast Quarter (SE4) of the Northwest Quarter (NW4); thence North 0°00' 121.5 feet to the Point of Beginning. Said parcel contains 1.2974 Acres, including 0.0920 Acres of County Road Right of Way.

The East line of the Southeast Quarter (SE4) of the Northwest Quarter (NW4) of said Section Ten (10) is assumed to bear due North and South.

## An undivided one-half interest:

All that part of the North 12½ acres of the West Half (½) of the Northeast Quarter (¼) of the Northwest Quarter (¼) lying South of the center of the public highway as now traveled, and containing .90 of an acre, more or less; and the North Half (½) of the Southeast Quarter (¼) of the Northwest Quarter (¼); the South 15 acres of the Northeast Quarter (¼) of the Northwest Quarter (¼); the Southeast Quarter (¼) of the Northwest Quarter (¼) of the Northwest Quarter (¼); and the East Half (½) of the Southwest Quarter (¼) of the Northwest Quarter (¼); all in Section Ten (10), in Township Seventy-five (75) North, Range Twenty-seven (27) West of the 5th P.M., Madison County, Iowa.
