- 4. I affirmatively state that the aggregate gross value of all property interests owned by Dennis D. Scar at the time of his death was below the filing requirements of a federal estate tax return and Iowa estate tax return, and that Dennis D. Scar's estate was not subject to federal estate tax, Iowa estate tax, or Iowa inheritance tax. Form 706, United States Estate Tax Return, is not required to be filed for Dennis D. Scar. Pursuant to Section 450.22(3), Code of Iowa, an Iowa inheritance/estate tax return was not required to be filed as a result of Dennis D. Scar's death.
