WHEREAS, a public hearing was held in the office of the Madison County Board of Supervisors at 9:05 A.M., January 28, 2014, pursuant to notice, in regard to vacating and abandoning the following described road(s):

Ohio Township - Sections 17/20

That part of a county road platted June 22, 1906, recorded in Road Book B, Page 283, on file in the Madison County Engineers Office, Madison County, located in Sections 17 and 20, Township 74 North, Range 26 West of the Fifth Principal Meridian, Madison County, Iowa, vacation of said county highway centerline (Terrace Ln.) described as follows:

Commencing at the Northwest corner of the Northwest Quarter (4) of said Section 20, Township 74 North, Range 26 West thus running 33 feet east to the point of beginning;

thence easterly along said county highway centerline (Terrace Ln.) approximately 488 feet to the end of the public roadway.

WHEREAS, no written or oral objections or claims for damages were received,

NOW THEREFORE BE IT RESOLVED, that the aforesaid road(s), as described, be vacated and any right, title or interest be abandoned.
