## SECOND REAL ESTATE CONTRACT EXTENSION

This is an Agreement, by and between, Exchange State Bank ("Sellers") and Alan W. Coombs ("Buyer") to extend the Real Estate Contract that was dated June 29, 2011, and recorded July 8, 2011, in Book 2011, Page 1789 of the Recorder's Office of Madison County, Iowa, and extended by a Real Estate Contract Extension dated August 29, 2013, and filed October 28, 2013, in Book 2013, Page 3265 of the Recorder's Office of Madison County, Iowa, covering the following-described real estate:

Lot One (1) in Block Twenty (20) of the Original Town of Winterset, Madison County, Iowa.

IT IS HEREBY AGREED that said Contract shall be extended from January 1, 2014, its previously extended end date, through June 1, 2014. Buyer shall pay to Sellers, by Direct Deposit from his bank account to an account of Seller's distinction, as follows:

Payments of \$299.53 per month, beginning April 1, 2014, and continuing each month thereafter until June 1, 2014, when a balloon payment for the remaining balance is due. Attached and incorporated herein by this reference is an Amortization Schedule showing the remaining

payments. Said payments shall be applied first to interest and then to principal.

Escrow for Taxes and Insurance: There will also be an Escrow Payment of \$407.39 per month, beginning April 1, 2014, and continuing each month thereafter, until the June 1, 2014, balloon payment. The Escrow Payment amount is subject to change based on increases or decreases in the insurance premium and taxes.

All other terms and conditions of said Real Estate Contract shall remain in full force and effect.
