BINDING ACKNOWLEDGEMENT for FUTURE INSTALLATION**

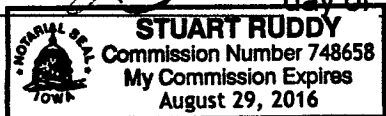

WHEREAS, the property located at 3315 Cumming Rd, Cumming, Iowa is subject to the inspection, and the buyer W.C. KNAPP REVOCABLE TRUST understands there is not a private sewage disposal system serving this property.

NOW THEREFORE, it is hereby agreed that the time of transfer inspection will not be required and agrees that the necessary private sewage disposal system to serve the property shall be installed and completed no later than 31st day of JULY, 2014.
