## AMENDMENT TO REAL ESTATE CONTRACT

This Amendment to Real Estate Contract made and entered into by and between Double D&E, LLC and Juan Lopez and Elizabeth Lopez, as Joint Tenants with Full Rights of Survivorship and Not as Tenants in Common, dated October 6, 2008, and recorded on October 23, 2008, in Book 2008, Page 3141 of the Recorder's Office of Madison County, Iowa.

WHEREAS, the entire balance is due and payable on November 1, 2013.

WHEREAS, the parties desire to amend said Contract to extend the final payment date.

NOW THEREFORE, it is agreed as follows:

- 1. The parties agree that this Contract shall be extended for five (5) years. Buyers shall continue to pay \$614.66 on the 1<sup>st</sup> day of each month until December 1, 2018, when the entire balance shall be due and payable. Said monthly payments shall be applied first to the interest then unpaid and next upon the balance of the principal.
