#### RESOLUTION

WHEREAS, on April 15, 2014, the Madison County Board of Supervisors proposes to vacate by this Resolution an alley in the unincorporated town of West St. Charles (now called Hanley), Madison County, Iowa. SEE EXHIBIT "A".

WHEREAS, Madison County proposes to convey by this Resolution the portion of said alley being vacated to:

- Cody Hutton and Tracy Hutton, as Joint Tenants with Full Rights of Survivorship and Not as Tenants in Common, which persons are the owners of the real estate adjacent to the part of the alley to be vacated and described as follows: SEE EXHIBIT "B".
- 2. Stephen Gene Harvey, which person is the owner of the real estate adjacent to the part of the alley to be vacated and described as follows: SEE EXHIBIT "C".
- 3. Jennie L. Holker and Josh Holker, as Joint Tenants with Full Rights of Survivorship and Not as Tenants in Common, which persons are the owners of the real estate adjacent to the part of the alley to be vacated and described as follows: SEE EXHIBIT "D".

WHEREAS, written and oral objections or claims for damages were received and reviewed, see attached.

NOW THEREFORE, BE IT RESOLVED by the Board of Supervisors of Madison County, Iowa:

- 2. That Madison County, Iowa, hereby conveys to Jennie L. Holker and Josh Holker, as joint tenants with full rights of survivorship and not as tenants in common, all of said real estate by this instrument and resolution as described in EXHIBIT "D".
- 5. That this instrument and resolution shall be filed and indexed as a conveyance by the Recorder and Auditor of Madison County, Iowa.
