AFFIDAVIT

State of Iowa, Jefferson County, ss:

I, Scott Jordan, do on oath state:

That I am a practicing attorney in Fairfield, Jefferson County, Iowa, and that I have practiced law for the past twenty-four years in said county.

That I was well and truly acquainted with Ira Nelson Crow during his lifetime and that I was attorney for the estate of Ira Nelson Crow, deceased.

That I know it to be a fact that the said Ira Nelson Crow departed this life testate in Fairfield, Jefferson County, Iowa, on the 10th day of May, 1950, that his Will was duly admitted to probate and his wife, Ermabeth Crow, qualified as executrix.

That under the terms of the Will of Ira Nelson Crow, deceased, his entire estate passed to Ermabeth Crow, surviving spouse.

That the State inheritance tax in said estate was paid in full and the receipt of the State Tax Commission was filed on November 7, 1950.

That there was no unpaid income tax in said estate and the release of the State Tax Commission was duly filed on the 13th day of December, 1950.

That said estate was relieved from all personal property tax and the certificate of the County Treasurer was filed March 5, 1951.

That a closing letter issued by Internal Revenue releasing said estate from Federal inheritance tax dated November 3, 1950, was filed July 21, 1951.

That said estate has been closed, court costs and attorneys fee have been paid in full and the executrix has been discharged.

ARTICLE I

The name of this association shall be PIONEER PLACE INC.

ARTICLE II

The principal place of business of this association shall be Earlham, Madison County, Iowa.

ARTICLE III
