Pursuant to the authority and power vested in the undersigned, and in consideration of One dollar and other valuable consideration, the undersigned, in the representative capacity designated below, hereby Conveys to Lizabeth Wyatt the following described real estate in Madison County, Iowa:

That part of the streets and alleys of the town of Barney platted May 11, 1887, recorded in Book 4, Page 156, Madison County Recorder's Office, Madison County, Iowa, vacation of streets and alleys described as follows: The North one-half of North Street lying North of Block 1, Block 2, Block 3 and Block 4, from 22,44 feet West of the Northwest corner of Lot 4, Block 4, East to the Northeast corner of Lot 1, Block 1; AND the South one-half of North Street lying North of Block 1, and Block 2, from 33 feet West of the Northwest corner of Lot 4, Block 2, East to the Northeast corner of Lot 1, Block 1; AND the East one-half of Center Street between Block 2 and Block 3, from the Northwest corner of Lot 4, Block 2, South to the Southwest corner of Lot 5, Block 2; AND Oliver Street between Block 1 and Block 2, from the Northwest corner of Lot 4, Block 1, South to the Southwest corner of Lot 5, Block 1; AND an Alley in Block 2, lying South of Lot 1, Lot 2, Lot 3, and Lot 4 of Block 2, and lying North of Lot 5, Lot 6, Lot 7, and Lot 8 of Block 2, from the Northwest corner of Lot 5, Block 2, East to the Northeast corner of Lot 8, Block 2; AND an Alley in Block 1, lying South of Lot 1, Lot 2, Lot 3, and Lot 4 of Block 1, and lying North of Lot 5, Lot 6, Lot 7, and Lot 8 of Block 1, from the Northwest corner of Lot 5, Block 1, East to the Northeast corner of Lot 8, Block 1; AND the North one-half of Spring Street lying South of Block 1,
