**ORDINANCE NO. 2037**

**AN ORDINANCE AMENDING THE CITY CODE OF THE CITY OF WEST DES MOINES, IOWA, 2014, TITLE 7 "PUBLIC WAYS AND PROPERTY," NAMING THAT ROADWAY CURRENTLY REFERRED TO AS '105<sup>TH</sup> STREET' AND INTENDED FOR CONSTRUCTION IN 2015, INCLUDING ANY FUTURE EXTENSIONS OR SEGMENTS WITHIN THE CITY OF WEST DES MOINES TO 'GRAND PRAIRIE PARKWAY'**

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF WEST DES MOINES, IOWA:**

**Section 1.** Title 7, "Public Ways and Property," Chapter 1 "Streets, Sidewalks and Alleys", Section 8 "Street Names", Paragraph D, "Official Street Name Map" is hereby amended by changing the name of that roadway and rights-of-way and all references thereto of 105<sup>th</sup> Street as currently intended to be constructed in the City of West Des Moines, including all future extensions and segments under the City of West Des Moines jurisdiction within Dallas and Madison Counties, Iowa, as conceptually shown on attached Exhibit A to Grand Prairie Parkway.


**Section 2.** Subsequent to its adoption and publication the Mayor and City Clerk shall certify and file this Ordinance with the County Recorder, County Assessor, and County Auditor of Dallas and Madison Counties, Iowa. Thereafter the County Auditor shall make proper changes on any plats found in the County Auditor's Office and the County Recorder shall enter the instrument into the record and make reference on the margin of the original plats of record or upon a reference sheet or page attached to the original plats for that purpose.

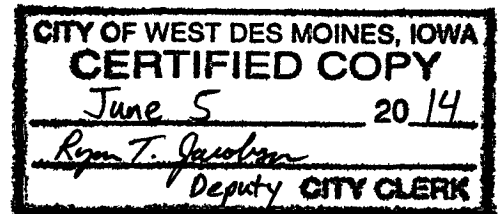
**Section 3.** Repealer. All ordinances or parts of ordinances in conflict with the provision of this ordinance are hereby repealed.

**Section 4.** Savings Clause. If any section provision, sentence, clause, phrase, or part of this Ordinance shall be adjudged, invalid, or unconstitutional such adjudication shall not affect the validity of the Ordinance as a whole or any provision, section, subsection, sentence, phrase, or part hereof not adjudged invalid or unconstitutional.


**Section 5.** Effective Date. This ordinance shall be in full force and effect from and after its passage, adoption, and publication as required by law.
