WHEREAS, a Transmission Line Easement exists on, over, under and across the following described property:

The Southwest Quarter of the Northeast Quarter (SW1/4NE1/4) of Section 1, Township 77 North, Range 27 West of the 5<sup>th</sup> P.M., Madison County, Iowa.

The transmission line shall be located within a strip of land 150 feet in width across the above described property and properties adjacent to it. The centerline of the said strip shall enter the property at a point approximately 970 feet East of the Northwest corner of the Southwest Quarter of the Northeast Quarter (SW1/4NE1/4) of Section 1, thence running Southwesterly to a point approximately 300 feet South of the Northwest corner of the Southwest Quarter of the Northeast Quarter (SW1/4NE1/4) of the said Section 1.

WHEREAS, MidAmerican Energy Company, successor in interest to Iowa Power and Light Company, is the owner of the said easement more particularly described as follows:

A Transmission Line Easement granted to Iowa Power and Light Company, an Iowa corporation, by Walter E. Eichner and Florence Faith Eichner, husband and wife, and recorded on December 3, 1968 at Book 96, Page 261 of the records of the Madison County Recorder.

NOW THEREFORE, MidAmerican Energy Company does hereby release unto the present owners, any right or interest, created by the above mentioned easement grant.

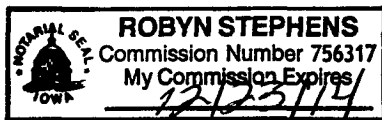
