



This agreement is entered into this 8th day of August, 2014 by and between Madison County Board of Health and Carrie Woodley.



WHEREAS, the property located at 3199 Limestone Avenue, further described as property located in the SE ¼ of the SW ¼ of Section 24 Monroe Township, Madison County Iowa, is subject to the inspection, and the buyer Carrie Woodley understands there is not a private sewage disposal system serving this property.

NOW THEREFORE, it is hereby agreed that the time of transfer inspection will not be required and agrees that the necessary private sewage disposal system to serve the property shall be installed and completed no later than the 1st day of July 2015.

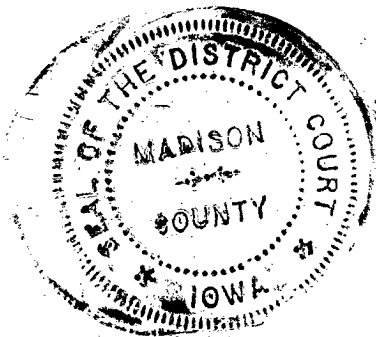


