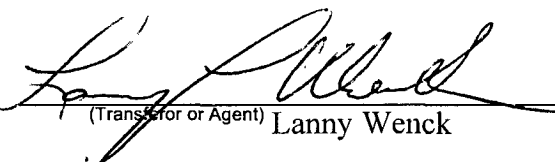

A part of Parcel "C" in the Southeast Quarter of Section 10, Township 75 North, Range 28 West of the 5th P.M., Madison County, Iowa more particularly described as follows:

Beginning at the Southeast Corner of the Southwest Quarter of the Southeast Quarter of Section 10, Township 75 North, Range 28 West of the 5th P.M., Madison County, Iowa; thence South $89^{\circ}16'31''$ West 815.84 feet along the South line of said Southwest Quarter of the Southeast Quarter, which is the South line of Parcel "C"; thence North $16^{\circ}29'55''$ East 557.60 feet; thence North $33^{\circ}32'02''$ West 330.92 feet; thence North $61^{\circ}15'01''$ West 50.02 feet to a point on the centerline of Pammel Park Road; thence North $28^{\circ}44'59''$ East 525.36 feet to a point on the North line of said Southwest Quarter of the Southeast Quarter; thence North $88^{\circ}41'45''$ East 642.18 feet to the Northeast Corner of said Southwest Quarter of the Southeast Quarter; thence South $00^{\circ}28'04''$ West 600.16 feet along the East line of said Southwest Quarter of the Southeast Quarter; thence South $86^{\circ}47'48''$ East 658.07 feet; thence South $00^{\circ}37'18''$ West 654.95 feet along the East line of Parcel "C" to the Southeast Corner of Parcel "C"; thence South $89^{\circ}16'31''$ West 655.71 feet to the Point of Beginning, containing 32.65 acres including 0.62 acres of County Road right-of-way.
