## LIMITED POWER OF ATTORNEY

CitiMortgage, Inc., ("Owner") a New York corporation duly constituted, registered with its principal place of business located in O'Fallon, Missouri, hereby constitutes and appoints ServiceLink, LLC, a ("ServiceLink"), a Pennsylvania corporation, as its true and lawful Attorney-In-Fact, and in its name, place and stead and for its use and benefits hereby authorizes the aforesaid Attorney-In-Fact by and through any officers appointed by the Board of Directors of ServiceLink to perform and execute documents customarily and reasonably necessary and appropriate, limited to the tasks described in items (i) through (iii) below. This Power of Attorney is being issued in connection with certain real property and any improvements and fixtures located thereon (together called "REO property") owned by Owner, necessary and incidental to managing and disposing of real properties and performing the obligations of ServiceLink:

To sign, execute, acknowledge, deliver, and revoke on behalf of the Owner, such Special Warranty Deeds, Limited Warranty Deeds, Warranty Deeds, or Quit Claim Deeds, as may be necessary for the conveyance of the REO property pursuant to the Vendor Services Agreement for REO Title and Closing Services ("Agreement"), at the closing of the sale of the REO property, but only with respect to said REO Property.

- (i) Endorsing to the order of ServiceLink any checks received in connection with the aforementioned REO property that are made payable to the order of Owner.
- (ii) Selling, transferring, managing, maintaining, disposing of, or leasing real property or personal property constituting REO properties assigned to ServiceLink, as defined under that certain Agreement between the parties hereto, and executing all contracts, agreements, deeds, assignments and other instruments including, but not limited to HUD-1 Settlement Statements, and any other documents (excluding releases and affidavits) necessary to effectuate any such sale, transfer or disposition or any lease and to receive proceeds and checks payable to the order of ServiceLink all in a manner consistent with such Agreement.
- (iii) Preparing, executing and delivering deeds, certificates of title or other title documents to vest title to real or personal property, including but not limited to mobile homes, modular homes or manufactured homes, in the sale, transfer, and conveyance of title or ownership rights of any REO property.

Owner gives to said Attorney-In-Fact full power and authority to do and perform all and every act and thing and whatsoever is necessary and proper to be done by authority hereof as fully, for all intents and purposes, as it, the Owner, might or could do and hereby ratifying and confirming all that said Attorney-In-Fact shall lawfully do or cause to be done by authority hereof. Third parties without actual notice may rely upon the power granted to said Attorney-In-Fact under this Power of Attorney and may assume that, upon the exercise of such power, all conditions precedent to such exercise of power have been satisfied and this Power of Attorney has not been revoked unless an Instrument of Revocation has been recorded.
