## Groundwater Hazard Statement.

### 1. Wells.

There were believed to be two wells on this property, which have been represented to have been plugged by a past tenant. Exact locations are not known.

### 2. Solid Waste Disposal

An old small house on the property was demolished at some time in the past by a past tenant, and buried at the site of the house.

### 3. Private Sewage Disposal System

There was an old small house on the property which was demolished at some time in the past by a past tenant. It was serviced by a private sewage disposal system. The house is demolished and non-existent. The old septic system is abandoned and not in use, however the septic tank and laterals may still be buried. Exact location is not known.
