Addendum

1. The North Half (N ½) of Lots Five (5) and Six (6) in Block Two (2) of Wilsey's Addition to the Town of Winterset, Madison County, Iowa; and a strip of real estate 132 feet long from East to West and 16 ½ feet wide from North to South, being real estate bounded by and included within a line commencing at the southeast corner of Lot Three (3) of Block Two (2) of Wilsey's Addition to the City of Winterset, Iowa, and running thence West 132 feet, thence South 16 ½ feet, thence East 132 feet, thence North 16 ½ feet to the place of beginning, being real estate which was vacated for alley purposes by an ordinance of the City of Winterset, Iowa.



Grantee herein is prohibited from conveying captioned property for any sales price for a period of thirty (30) days from the date of this deed. After this 30-day period, Grantee is further prohibited from conveying the property for a sales price greater than \$107,000.00 until ninety (90) days from the date of this Deed. These restrictions shall run with the land and are not personal to Grantee.
