AFFIDAVIT EXPLANTORY OF TITLE

We, the undersigned, as Co-Trustees of the Mildred D. Smith, a Revocable Living Trust dated December 17, 2010 (the "Trust"), being first duly sworn, depose and state as follows:

- 1. We have personal knowledge of the facts stated herein.
- 2. We are familiar with title to certain real estate located in Madison County, Iowa, more particularly described as:

The Southwest Quarter (SW ¼) of the Northwest Quarter (NW ¼) of Section Twenty-six (26) AND the East Half (E ½) of the Northeast Quarter (NE ¼) of Section Twenty-seven (27), all in Township Seventy-seven (27) West of the 5th P.M., Madison County, Iowa (the "Real Estate").

- 3. The Real Estate is located in Sections 26 and 27, Township 77, Range 27 in Madison County, Iowa.
