Addendum

The East Half (E 1/2) of the Southwest Quarter (SW 1/4) of the Southeast Quarter (SE 1/4) and the Northwest Ouarter (NW 1/4) of the Southwest Ouarter (SW 1/4) of the Southeast Ouarter (SE 1/4), all in Section Eight (8), Township Seventy-four (74) North, Range Twenty-eight (28) West of the 5th P.M., Madison County, Iowa; And, a tract of land described as follows, to-wit: Commencing at the southwest corner of the East Half (E 1/2) of the Southeast Quarter (SE 1/4) of Section Eight (8), running thence North along the West line of said 80-acre tract for a distance of approximately 78 rods to the point where the west line of said 80-acre tract crosses the main channel of Clanton Creek, thence South and East along the center of the channel of Clanton Creek to the point where the center of the channel of Clanton Creek crosses a line drawn from the Northwest corner to the Southeast Corner of the Southwest Quarter (SW 1/4) of the Southwest Quarter (SW 1/4) of Section Nine (9); thence southeast along said line to the southeast corner of said Southwest Quarter (SW 1/4) of the Southwest Quarter (SW 1/4); thence West along the south line of said Sections Nine (9) and Eight (8) to the point of beginning, all in Township Seventy-four (74) North, Range Twenty-eight (28) West of the 5th P.M., Madison County, Iowa, containing 17 acres, subject to easements of record.

THIS DEED IS GIVEN TO CORRECT AND CLARIFY THE CHAIN OF TITLE ESTABLISHED BY THE DEED RECORDED AT BOOK 2002, PAGE 3411 AND IN CONNECTION WITH A TRANSACTION BETWEEN A FAMILY BUSINESS CORPORATION AND A RELATED FAMILY LIMITED LIABILITY COMPANY, BOTH AS REFERRED TO IN IOWA CODE SECTION 428A.2; THERE IS NO ACTUAL CONSIDERATION; THIS TRANSACTION IS EXEMPT FROM REAL ESTATE TRANSFER TAX.
