The undersigned hereby certify that Pizza Ranch of Winterset LLC (hereafter Owner) is the owner of real property in Winterset, Madison County, Iowa, that is legally described as follows:

Lot Five (5) of the Replat of Lot Three (3), Gold Buffet Subdivision, City of Winterset, Madison County, Iowa, according to the Final Plat filed of record July 24, 1998, in Book 2, Page 367 in the records of the Madison County Recorder,

as recorded with the Madison County Recorder on August 15, 2014 in Book 2014, at Page 2033, locally known as 1009 N. First Street, Winterset, Iowa,

Parcel "R" in the Northwest Quarter of the Northwest Quarter of Section 31, Township 76 North, Range 27 West of the 5th P.M., City of Winterset, Madison County, Iowa, being the Easterly 30.00 feet of Right-of-Way of John Wayne Drive (North First Street) adjacent to Lot 5 of Replat of Lot 3 of the Gold Buffet Subdivision more particularly described as follows:

This Covenant and Agreement shall run with all of the above-described land and shall be binding upon Pizza Ranch of Winterset LLC, and future owners, encumbrances, their successors, heirs and assignees, and shall continue in effect until released by the authority of the Mayor of the City of Winterset, Iowa, upon submittal of request, applicable fees and evidence that this Covenant and Agreement is no longer required by law.
